All applications must be postmarked or faxed (802-824-3659) to Bromley by May 15, 2019. Applications submitted after this deadline will not be accepted.

This installment plan agreement is between you and SKI BROMLEY, LLC, a Vermont limited liability company ("Bromley"). By signing this document, you agree as follows:

- You will pay for the season passes listed above in three equal installments with your credit card. The first installment will be charged to your credit card upon Bromley's receipt of this signed agreement. The second installment will be charged to your credit card on August 1, 2019, and the final installment will be charged to your credit card on November 1, 2019. Your credit card statement for the installment charges will reflect one charge for each of the passes that you purchase through this agreement.
- You will provide your credit card information with this agreement. *Debit cards are not accepted.* Bromley will keep that information on file for the sole purpose of charging that card for the passes on the dates mentioned. The credit card you provide must have a valid expiration date through November 30, 2019. You authorize Bromley to prepare and submit charge slips to your credit card for any transaction covered by this agreement to recover all charges and other unpaid amounts due.
- You will contact the Bromley ticket office immediately at (802) 824-5522 ext. 710 if the credit card provided is lost or stolen, or if the credit card numbers or details change in any way. You will make payment for all amounts charged if the credit card provided expires or is invalid, or any of the charges are not paid by the credit card issuer.
- 2019/20 passes purchased this season are valid for the remainder of the 2018/19 season (except for parking & seasonal programs). If you are not a current season pass-holder and enter the payment plan agreement, you will be issued a lift ticket for each day you ski at the end of the 2018/19 season. Stop at guest services with a form of identification to receive day ticket. You must return to the ticket office next fall for your 2019/20 season pass after all payments are made in full. You will not be entitled to your 2019/20 season pass, or the benefits provided under the season pass, until *all* installment payments have been paid in full. Your season pass can be revoked without prior notice if the pass has been issued and for any reason any charges to your credit card are later denied, challenged or cancelled.
- Once you sign this agreement and deliver it to Bromley, you acknowledge and accept full responsibility for these terms and guarantee payment for all of the season passes purchased. Bromley may pursue all avenues of collection, including the use of collection agencies if you fail to pay, and may recover from you all commissions paid, losses, attorney fees, costs and expenses incurred with collection.
- When your installments have been paid in full, you agree to deliver to Bromley a signed season pass waiver of liability form for each pass holder listed on this agreement. Adult pass holders will each sign a waiver and the parent or legal guardian of each minor pass holder will sign a waiver on behalf of that minor pass holder. Passes will not be issued and effective until all such forms are signed and returned.
- This agreement is governed by Vermont law. Any claim or action involving parties or issues relating to or arising out of this agreement must be brought exclusively in state civil court in Bennington County, Vermont, or federal courts in Vermont. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
